

# MOSQUITO REPELLENT BRACELETS -

## PRODUCT CHARACTERISTICS

**Use:** Mosquito protection to be used in non-malaria-infested areas. Effective against mosquitoes. Tested by the University of Jerusalem's Center for the Study of Infectious and Tropical Diseases. Ideal for outdoor activities, travel and at home.

**Composition:** LDPE bracelet impregnated with 16% geraniol (on the active part of the bracelet)

## PRODUCT DESCRIPTION & BENEFITS

- Active principle: geraniol comes from the cymbopogon plant. This active principle has been pre-registered EU health authorities for the European Biocidal Products Regulatory (CAS registry no: 106-24-1).
- The Pharmavoyage mosquito bracelet has a repellent effect of approximately 1 meter.
- Effect lasts 3–4 weeks after opening the protective pack (120 hours: 3 to 4 hours per day).
- Adjustable, fits adults and children (aged 30 months and up)
- Biodegradable, made from LDPE (guaranteed phthalate-free).

## RECOMMENDATIONS

For maximum effectiveness, wear one bracelet on the ankle and one on the wrist. Adjust the bracelet so that the two-tone side is not in contact with the skin (do not wear while sleeping). For maximum effectiveness, do not tighten the bracelet – it should be worn loose around the wrist or ankle. After each use, replace the bracelet in the resealable pack supplied.

## LIMITS AND RESTRICTIONS ON USE

Do not use if allergic to terpenes. A slight prickling sensation may be experienced. These are temporary and are linked to the activity of the product. In case of strong allergic reactions, remove the bracelet, rinse with soap and water. To avoid a possible skin reaction due to the essential oil and to optimize the effectiveness, never tighten the bracelet on the skin but wear loose. Avoid sleeping with bracelets on (you can, however, hang them at the foot and head of the bed). In case of bathing, it is necessary to wait nearly 2 hours for the bracelet to regain its repulsive properties. For protection against vector-borne diseases (malaria, dengue, chikungunya, zika, etc.), Pharmavoyage bracelets should be used in conjunction with a suitable repellent (e.g. Biovectrol eucalyptus with citriodiol). Causes serious eyes damage. Causes skin irritation. May cause an allergic skin reaction. Keep out of reach of children. Wash hands thoroughly after handling. In case of contact with eyes: rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. In case of skin contact: wash with plenty of water. If skin irritation or rash occurs: get medical advice/attention. Use biocides safely.
